



Disclosure Of Interest Register – NZFC Board

This register lists NZFC Board Members’ interests that have arisen in the last 24 months, and any historical interests, that could affect a Member’s work and result in an actual, or potential, conflict of interest.

If a Member has a perceived or actual conflict, under section 66 of the Crown Entities Act 2004, the Member cannot:

- Vote or take part in any discussion or decision of the Board or any committee relating to the matter, or otherwise participate in any NZFC activity relating to the matter;
- Sign any document relating to entry into a transaction or initiation of the matter; and
- Be counted toward the quorum for a Board meeting during which a discussion or decision relating to the matter occurs or is made.

However, under section 68, the Chair may provide written notice to the Board stating they permit a Member to do any of the above, despite their conflict and in line with any conditions set by the chair. These permissions form “Management Plans” which are recorded in this register.

Types of interest

Financial The interest has a financial value. I am expected to gain some financial benefit or loss from the interest, or have a financial interest in person to whom the matter relates	Professional I have professional contacts with other organisations, associations and/or trusts that could be in either reality or perception considered a conflict of interest. Generally, an active association within the last 24 months would be relevant to this category.	Personal Relationship I have family relationships and/or friendships which could be perceived as a conflict.
Non-financial My position or authority is or may be used to influence or make decisions that lead to any form of personal gain for me, my family members or personal associates.	Political I have political involvement that could conflict with my duty to act in a politically neutral manner, or my political involvement could appear to compromise my ability to make decisions in the best interests of the organisation.	Other I have an interest that does not fit in any of the other categories, but I believe this interest may raise a conflict or potential conflict of interest.
