19 JULY 2021: OFFICIAL INFORMATION ACT REQUEST

In your email dated 19 July 2021 you requested the following information under the Official Information Act 1982 (OIA):

1. all documents, emails, notes, briefings, diary notes etc. relating to other proposals for concepts relating to the March 15 terror attack.

Documents in relation to your request are attached at **Appendix 1.**

Information has been withheld in full or redacted where one of the following withholding grounds under the OIA applies and where, on balance the withholding of the information is not outweighed by other considerations which render it desirable, in the public interest, to make that information available:

- Section 6(d): where the making available of information would be likely to endanger the safety of any person;
- Section 9(2)(a): to protect the privacy of natural persons;
- Section 9(2)(b)(ii): to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information; and
- Section 9(2)(ba)(i): to protect information which is subject to an obligation of confidence, where the making available of the information would be likely to prejudice the supply of similar information, or information from the same source, and it is in the public interest that such information should continue to be supplied.

We have not included information or correspondence that is of an administrative or trivial nature (for example, to arrange meeting times) as we suspect this type of communication is likely out of the intended scope of your request and in any event, would be withheld under section 18(h) of the OIA.

In the 2020/21 financial year, the NZFC awarded \$24,000 in Documentary Development Funding to a project titled *Fiftyone*. The decision meeting was held on 19 May 2021. Key creatives involved in the project are Virginia Wright (Producer), Vanessa Wells (Director), Saba Afrasyabi (Co-producer/Co-director) and Bariz Shah (Co-producer/Co-director).

Please note this project is not about the March 15 terror attacks, however, as it is related, we have included it in the scope of your request.

Fiftyone is a feature documentary told through the eyes of Bariz Shah and Saba Afrasyabi – a young Afghan-New Zealand couple, who in remembrance of the 51 people killed in Christchurch's two mosques on March 15, 2019, travel to Afghanistan to empower some of Kabul's most poverty-stricken people through 51 micro-business projects.

A full synopsis of the project is attached at Appendix 2.

All documents, emails, notes, briefings and diary notes in relation to *Fiftyone* have been withheld in full where one of the following withholding grounds under the OIA applies and where, on balance the withholding of the information is not outweighed by other considerations which render it desirable, in the public interest, to make that information available:

- Section 9(2)(b)(ii): to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information; and
- Section 9(2)(ba)(i): to protect information which is subject to an obligation of confidence, where the making available of the information would be likely to prejudice the supply of similar information, or information from the same source, and it is in the public interest that such information should continue to be supplied.

Please note that we will be publishing this letter (with your personal information removed) on the NZFC website.

You have the right, by way of complaint to the Ombudsman under section 28(3) of the Official Information Act, to seek an investigation and review of our response.

Thanks for your patience.

Annabelle and I have had a chat—as is always the way, she's also been approached by producers with another project on the 15 March terrorist attack—and we would like to suggest a meeting with Moez Masoud here in Cannes at his earliest convenience.

The focus of this meeting would be to introduce the NZFC and wider NZ industry. While we wouldn't be seeking to dissuade him from any media announcement here in Cannes—which is entirely his prerogative—we would be making it clear to him (delicately) that there can be no explicit or implied support or endorsement of the project by the NZFC or wider NZ Government at this very early stage of engagement.

Are you able to introduce him to me over email, to liaise on scheduling an introductory chat? We'd like to meet as soon as possible, in advance of any potential media activity.

Hi Chris - good to talk on Friday.

As discussed, our Embassy in the UAE has been approached by a film-maker Moez Masoud https://en.wikipedia.org/wiki/Moez_Masoud to make a feature film focusing on the aftermath of the Christchurch Attacks. He has the support of the UAE government, who arranged the call.

The outline of his proposal for the film "Hello Brother" is at the bottom of my email. In discussions with the NZ Embassy in the UAE, Moez acknowledged that the timing could be seen as premature and that this would normally be something undertaken 5 years after an event but he thinks others are going to act. He argued that based on the strong support for NZ from the UAE, as well as the way NZ responded to the attacks, his story would be meaningful and favourable for NZ. He also wanted to assure us that this was still a longer term (ie 18mth- 2 year) project. However, commercial realities mean he needs to take some steps now to (a) head off competitors; (b) fit with his schedule (he has other projects on the go); and secure funding.

He therefore needs to visit now to understand NZ and commence research/info gathering for the project. He needs to start writing now to have the script complete in 6 mths. We understand he is planning a visit in the next month or so.

He says the budget is about and he's basically secured the funding already (the Embassy is assuming UAE funders). He says he has also secured Executive Producers and a script writer.

Moez is attending Cannes in the next couple of weeks and will be making an announcement about the film "Hello Brother". The Embassy questioned the timing and purpose. It seems the main purpose is to get ahead of the competition and he described it as an "inside industry" type announcement which is how these things begin. The Embassy has also provided contact details for the New Zealand Film

Commission.

I have also met with the UAE ambassador here, and expressed some unease about the timing of the visit, particularly if he plans to meet with victims' families. Our understanding is that he plans to engage through one of the Imams in Christchurch.

Moez has asked to meet with me when he visits. From an MFAT perspective we want to ensure that there is no official government endorsement of this initiative particularly at this early stage. My strong preference would also be to ensure that any proposals to make a film about the Christchurch Attacks be managed through the New Zealand Film Commission, as we would want to ensure that any product was sensitive to those impacted by the attacks, especially the families, and took into account how any such film might be perceived in New Zealand.


On that basis – we would be keen to ensure that you or one of your colleagues met with Masoud when he visits New Zealand.







Three powerful media projects to commemorate one year since March 15



Three projects that will commemorate the one year anniversary of the March 15 terror attacks have been funded as the final initiatives from the RNZ/NZ On Air Joint Innovation Fund.

NZ On Air received 14 applications in response to a request for proposals issued in May, which sought media projects to mark the anniversary of the attacks, and honour the victims and their families.

The three projects were selected in consultation with a New Zealand Muslim community leader. Each project will be published on the RNZ website and complement RNZ's ongoing coverage of the events and issues related to the attacks.

A podcast series with accompanying photography, *The Widows Of Shaheed* will journey alongside four women whose husbands were killed on March 15. From the Hajj pilgrimage to Mecca in August through to the impending first anniversary of the attacks, this series will chronicle the

realities these women face as they adjust to life after March 15.

The Living Flowerwall is an interactive project that digitally renders Christchurch's wall of flowers on Rolleston Ave that became a symbol of the city's grief and unity in the days and weeks following the attacks. The online shared space will allow members of the public to add messages and virtual flower bouquets.

This Is Us is a series of six short films which will showcase the diversity of Muslim New Zealanders experiences as they answer the question "what do you love the most?" In talking about what they each love the most, the series will provide a platform for each person to represent who they are, how they feel, and how different or similar their journey has been to other Muslim New Zealanders.

"With almost five months having passed, it's clear that the events of March 15 have had a profound and lasting effect on the nation and our people," says NZ On Air Chief Executive Jane Wrightson.

"The coming months will continue to be a tough journey for all directly and indirectly affected. NZ On Air is very pleased to support three projects that will, in a time of grief and reflection, create korero that shines a light on our similarities, differences and joint hope for the future," she continued.

"RNZ continues to provide in-depth coverage of issues related to the Christchurch terror attacks of 15 March 2019 through our high-quality day to day and long form investigative journalism," says RNZ Chief Executive Paul Thompson.

"We're proud to support these independent content creators who are showcasing three very different projects. These powerful stories will provide deep insights from a wide range of perspectives as well as new opportunities for engagement and ongoing support from the wider New Zealand community."



A quick note to say that following the engagement in Cannes, we've heard nothing from Moez or his team. I suggested a call at one stage which he was interested in, but then nothing materialised. Has he engaged with you/the post on this in the intervening period, Matt?

Additionally (and the prompt for sending you both this email) – we've separately been approached by the international co-productions unit of Turkish Radio and Television (TRT) regarding a feature film project based on the same topic. TRT develops, invests in and produces projects with partners around the globe, with a focus on feature films and tv series (both traditional and digital).

For clarity, I'm also updating Wendy Hinton on this aspect.

I met two of their team (Merve ZORLU and Güneş ÇELİKCAN) in Seoul at the International Broadcast Co-Production Conference in June 2019 and they've followed up via email since. We've provided a materially similar message to them, as we did to Moez and his colleagues re: their proposed feature, regarding the nuts and bolts of working with/in the NZ screen sector, and timing/sensitivity considerations.

Their approach: "We think the subject matter is very relevant and the inclusive and sensitive response of New Zealand to these terrorist attacks is very valuable."

Thanks for your note and some brief context follows – I'm on leave from today for a week but was keen to provide headlines.

I'm cc'ing Mladen here, too for his info.

- I met the pair recently in Seoul at an international broadcasting co-production conference cohosted by our sister agency for television co-productions under the Korea-NZ treaty, the Korea Communications Commission (KCC) at which they and I were invited speakers.
- Merve followed up over email subsequently, expressing TRT's interest in co-production activity (both TV and film).
- I've briefed them on the fact that there's no treaty, which does make it tricky (albeit not impossible), particularly with respect to NZFC production equity (for film) and the New Zealand Screen Production Grant (NZSPG) 40% rebate for NZ productions and official co-productions (film and TV).
- I've outlined the low likelihood of a treaty being negotiated, ratified and entering into force in the foreseeable future, given MCH not prioritising new bilateral treaties.
- That said, of note is that Turkey is a signatory to the European Convention on Cinematographic Co-Production (ETS 147), which the Council of Europe Convention on Cinematographic Co-Production (ETS 220) supersedes. The (internationalised) CoE Convention offers a number of benefits to NZ, including improved ability to co-produce along both bilateral and multilateral lines with EU partners. Mladen and I have obtained the support of our Board to apply to accede, a position that has also gained the support of our producing community and your EUR division, and we're working with the latter to try to get MCH to support this.
- A key reason for the TRT visit is their proposed feature film about the Christchurch mosque attacks – one of at least three such projects of which we're aware, including Hello Brother that was announced while we were in Cannes in May (and with whose principals our CEO and I met, on referral from Matt Hawkins in Abu Dhabi and Stu Horne in your MEA division who've had engagement with that project's high-profile instigator, Moez Massoud who sought to meet with PM Ardern directly during an upcoming visit, which both MFAT and NZFC advised was not likely to be possible).
- Merve has outlined the following: "We think the subject matter is very relevant and the inclusive and sensitive response of New Zealand to these terrorist attacks is very valuable."
- It goes without saying that there are considerable challenges facing feature film projects that focus on this topic, given the continuing sensitivity, how fresh the hurt still is and who has the "mantle" to tell this story (this NZH article in response to the Hello Brother announcement is salient).

	A crucial consideration in the context of NZFC engagement is		
	to take on a film dealing with this subject in the near		
	future (which is required to trigger eligibility to apply for NZFC production equity and/or the		
	NZSPG).		

• We've communicated this wider sentiment to Merve and Güneş and the *Hello Brother* team, while continuing to be facilitative and providing information/referrals.

•	I provided Merve and Güneş a list of NZ feature film producers with prior international feature
	film co-production experience or equivalent multi-party financing experience,

 In her most recent correspondence with me, Merve indicated they were looking to visit NZ in mid-September and requested a follow-up meeting. I also supplied the attached NZ On Air announcement, relating to projects which that agency has recently funded on the topic, for TRT's interest.

Should you be keen to do so, from our perspective it would be useful for you to meet with Merve and Güneş to:

- help reinforce messaging to date about the sensitivity of the subject matter, and the need to proceed respectfully and with due process;
- develop a relationship with the pair personally and TRT's International Co-Production Unit more generally; and
- glean any useful context about TRT, its levels of financing, international activity and any
 political/censorship/editorial/other issues of which we (NZFC and NZ screen sector
 practitioners) should be cognisant in the course of further engagement.

I hope this provides good context, and look forward to hearing how your meeting goes, should one proceed.

If it's a feature film, then the NZ producer would apply to us for development/production funding and/or NZSPG 40% approval (if it meets the Significant NZ Content Test outside an official co-production and the NZ producer shares equity in the production) or you would apply for the NZSPG 20% if you're just shooting and/or post-producing here (and the NZ producer is solely a service producer i.e. no equity ownership in the production).

If it's a television show, then our involvement is solely co-production approvals and NZSPG administration. So the same process would apply re: NZSPG 40% or NZSPG 20% as outlined above for feature films.

I'm due to meet with NZ On Air's Head of Funding, Amie Mills over the coming days for a catch-up, so I'll mention your interest to her then, and we can go from there re: connecting you.

Our Embassy in Ankara had some engagement with a Turkish filmmaker, Tuncer SAKGÜN (who ran a Turkish Film Festival here briefly) and the Turkish Directorate of Cinema (Ministry of Culture and Tourism) in 2016. We have not heard further from Tuncer since.



Regarding the 15 March 2019 terrorist attacks, we're aware of two proposed feature films about this topic, including one (Hello Brother) by Moez Masoudhttps://en.wikipedia.org/wiki/Moez_Masoud which was announced at Cannes this year. We met with Moez and his producer to discuss the project at Cannes, and provided an overview of the NZ industry, forms of support and to encourage the filmmakers to collaborate with appropriately experienced NZ partners and to ensure strong support for the project from the Christchurch Muslim community.

We tend to focus much of our co-production activity on our 17 official co-production treaty partners (listed at the preceding link). We don't (yet) have a co-production treaty with Turkey, though I am aware that Turkey has ratified the European Convention on Cinematographic Co-Production, so if New Zealand was to accede to the Council of Europe Convention on Cinematographic Co-Production (revised) in the future, then it could be possible to use that instrument for official co-production between our two countries.

I raise this as official co-production feature films are automatically eligible for NZFC production finance and/or the 40% New Zealand Screen Production Grant (NZSPG). It's possible for unofficial co-productions to be eligible for one/more of these support structures for feature films, but it's a little more challenging.

That said, we're open to supporting unofficial co-productions where we can, and I'd be happy to make some suggestions for potential feature film/series partners here in NZ if you're able to provide me with an overview of the types (genre) of productions you're most interested in/focused on, including the scale (budget-wise) of projects.

Three projects that will commemorate the one year anniversary of the March 15 terror attacks have been funded as the final initiatives from the RNZ/NZ On Air Joint Innovation Fund.

NZ On Air received 14 applications in response to a request for proposals issued in May, which sought media projects to mark the anniversary of the attacks, and honour the victims and their families.

The three projects were selected in consultation with a New Zealand Muslim community leader. Each project will be published on the RNZ website and complement RNZ's ongoing coverage of the events and issues related to the attacks.

A podcast series with accompanying photography, The Widows Of Shaheed will journey alongside four women whose husbands were killed on March 15. From the Hajj pilgrimage to Mecca in August through to the impending first anniversary of the attacks, this series will chronicle the realities these women face as they adjust to life after March 15.

The Living Flowerwall is an interactive project that digitally renders Christchurch's wall of flowers on Rolleston Ave that became a symbol of the city's grief and unity in the days and weeks following the attacks. The online shared space will allow members of the public to add messages and virtual flower bouquets.

This Is Us is a series of six short films which will showcase the diversity of Muslim New Zealanders experiences as they answer the question "what do you love the most?" In talking about what they each love the most, the series will provide a platform for each person to represent who they are, how they feel, and how different or similar their journey has been to other Muslim New Zealanders.

"With almost five months having passed, it's clear that the events of March 15 have had a profound and lasting effect on the nation and our people," says NZ On Air Chief Executive Jane Wrightson.

"The coming months will continue to be a tough journey for all directly and indirectly affected. NZ On Air is very pleased to support three projects that will, in a time of grief and reflection, create korero that shines a light on our similarities, differences and joint hope for the future," she continued.

"RNZ continues to provide in-depth coverage of issues related to the Christchurch terror attacks of 15 March 2019 through our high-quality day to day and long form investigative journalism," says RNZ Chief Executive Paul Thompson.

For clarity, I look forward to seeing you next week, at 2pm Friday 20 December here at the NZFC.

I've also invited Mladen Ivancic—who I'm aware you know—to join our meeting should he be available to do so.

FYI the TRT team decided not to meet in Christchurch with the NZ producers and screenwriters, on the grounds that it wasn't appropriate or sensitive to do so when the defendant is back in court. The TRT team is in Wellington currently, then Christchurch on Wednesday & Thursday, and will then probably spend Friday in Auckland before flying back to Turkey on Saturday.

I trust this finds you and your colleagues at the post well.

I'm cc'ing Matt and Stu here for completeness, given earlier engagement with the pair in relation to a proposed feature film about the March 15 terror attacks, <u>Hello Brother</u> whose key creative, Moez Masoud met with my CEO and me at the Cannes Film Market in May on referral from Matt. Following some initial subsequent engagement with Moez, we've heard nothing since.

Most salient for you and the post is an additional feature on the same topic in early development by the international co-productions unit of <u>Turkish Radio and Television (TRT)</u>. As I'm sure you'll be aware, TRT develops, invests in and produces projects with partners around the globe, with a focus on feature films and tv series (both traditional and digital).

I met two of their team (Merve ZORLU and Güneş ÇELİKCAN) in Seoul at the International Broadcast Co-Production Conference in June 2019 and they've followed up via email since. We've provided a materially similar message to them, as we did to Moez and his colleagues re: their proposed feature, regarding the nuts and bolts of working with/in the NZ screen sector, as well as gently touching on timing/sensitivity considerations.

TRT's approach: "We think the subject matter is very relevant and the inclusive and sensitive response of New Zealand to these terrorist attacks is very valuable."

They're connected with two experienced NZ feature film producers and an experienced NZ screenwriter, and have been in touch with me this week to advise that they arrive in NZ on 8 December, along with a colleague from TRT London, Faith Er. They're visiting Wellington first to meet with FIANZ and others (incl. NZFC – we're due to meet here on 10 December) and will then move to Christchurch to meet the NZ producers and screenwriter, along with the community and the families of the victims. All appointments are being handled directly by TRT directly.

I'm very happy to update you following our meeting on 10 December, and grateful for any feedback/comments ahead of this meeting, should you wish to provide any.

Finally, and for general information/completeness, we're aware of a third feature film in development on the same topic; this one is by a leading NZ producer and an LA-based acclaimed NZ writer/director, working with a top UK producer.

A young Afghan-Kiwi couple journey from New Zealand to Afghanistan to change 51 lives, including their own, in honour of those killed in a terrorist attack in their home town of Christchurch.

SHORT SYNOPSIS: 250 words max

Shocked into action by the massacre of 51 people in their community in the Christchurch mosque attacks in 2019, Bariz Shah and Saba Afrasyabi are flying to Afghanistan to change the lives of some of Kabul's most desperate people.

"fiftyone" is an inspiring feature documentary told through the eyes of Bariz and Saba using personal interviews and their own footage filmed over 3 months in Afghanistan.

Before leaving New Zealand they raised money to initiate 51 microbusinesses in honour of those martyred in Christchurch.

With determination and tenacity Bariz and Saba gain incredible intimate access to the lives of their fund recipients. These people's stories weave together with their own private story, exposing hardship and loss while also sharing the dramatic positive changes micro-businesses can bring.

Powerful archive footage shows the war-torn and dangerous edge of Afghanistan, yet Saba and Bariz's camera finds heart- wrenching emotion and beauty too, showing a side of Kabul that is rarely seen.

Bariz and Saba's personal anguish is uncovered as they bring together their first and third world lives, and there are limits to what they can achieve. They feel they belong to neither Afghanistan nor New Zealand. Through honest interviews they reveal their family history, inner thoughts and difficult past as refugees.

As the film ends, they return to New Zealand changed in their own lives too with the birth of their first child in late 2020. They go forward into the future as determined as ever to use their positive energy for good.
